Main purpose of job

Be responsible to the Strategic Category Manager for the provision of professional advice, guidance, training and support in all areas of procurement.

Assist the Strategic Category Manager and Category Officers in managing third party expenditure.

Assist with researching products, services and suppliers, and provide the necessary technical support to enable the unit to achieve its targets to help maximise value for money in procurement matters and operational management of co-ordinated contracts.

Summary of responsibilities and personal duties

1. Assist the Strategic Category Manager and Category Officers in delivering and supporting high quality procurement and category management to achieve value for money and legislative compliance.
2. Develop and maintain a comprehensive knowledge and, or database of available frameworks.
3. Deliver the end-to-end tendering process for assigned work, such as managing and evaluating tenders, co-ordinating responses to tender enquiries and responding to complaints and appeals as appropriate and reporting on results.
4. Assist with procuring goods and services obtained via the Crown Commercial Services or other frameworks (i.e. for tenders managed by the Commercial and Procurement Services function).
5. Provide guidance and advice to departments on effective procurement process and provide council oversight by monitoring and maintaining the contract register.
6. Monitor the rationale and outcomes of local versus framework procurements.
7. Assist in developing, implementing and reviewing the procurement guidance and procedures for the council taking account of EU public procurement regulation and other relevant legislation.
8. Assist in the development and implementation of procurement training throughout the council.
9. Assist with the maintenance and management of procurement databases and information on the council intranet and internet sites.
10. Have up-to-date knowledge and understanding of procurement strategies, systems, legislation and procedures.
11. Undertake appropriate research and provide advice to departments on new and alternative products, services, suppliers and procedures as required under direction.
12. Provide general support and cover within the function, with particular requirements to cover SAP/SRM activity in the absence of the Procurement Analyst.
13. Represent Belfast City Council at external events and provide advice and guidance to external customers on procurement matters as appropriate.
14. Produce, collate and analyse service performance data and assist in the development of reports, briefing papers, presentations etc. as required.

15. Take part in working groups, projects teams, consultative and other groups as required.
 16. Participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including, absence management, disciplinary and grievance procedure.
 17. Participate as directed in the council's recruitment and selection procedures.
 18. Act in accordance with council and departmental policies and procedures including customer care, equal opportunities, health and safety and any pertinent legislation.

Belfast City Council is the Data Controller under the General Data Protection Regulations (GDPR) for the personal data it processes relating to job applicants. Appointment

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There is currently one permanent, full time post.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. **These posts may be on a permanent or temporary basis.**

An existing permanent employee will be offered a temporary post on the basis of undertaking a 'temporary project/cover/review' post with the right to return to his or her substantive post at the conclusion of the 'temporary project/cover/review' post. An existing fixed term contract employee will be offered a temporary post on the basis of a further fixed term contract in a 'temporary project/cover/review' post but with no automatic right to revert back to his or her original fixed term contract post. Fixed term contract employees should give consideration to this prior to applying for or accepting another post on a temporary basis.

Only Belfast City Council employees, who are employees as at the closing date for this post and who continue to be employees throughout the selection process for this post, are eligible to apply. Agency assignees and casual workers, who are not Council employees, are not eligible to apply. Applicants who are no longer current employees as at the short-listing, testing/assessment or interview stage will not be eligible to progress through the process, even if they were an employee at the closing date for receipt of applications. Similarly, if placed on the reserve list, applicants must still be current employees as at the point in time that a vacancy arises. This has always been the agreed practice within Belfast City Council and it is of critical importance that it is strictly adhered to especially during this period of significant re-organisation and change when the Council is striving to achieve permanency and stability.

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary Scale 5, SCP 12 to 17, £21,589 - £23,836 per annum (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

Location

The person appointed will be based initially in 9 Adelaide, 9-21 Adelaide Street, Belfast but will be required to work in and, or visit other locations.

Pre-employment checks

Prior to taking up duty the person recommended for appointment must:

Council policies

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements.

Conditions

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment.

Hours of duty

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed may be required to start and finish work at specific times that suit the operational needs of the service and she/he may also be required to work outside of these hours.

Annual leave

The person appointed will be entitled to 21 days annual leave plus 12 bank or other holidays.

Leave entitlement will be increased by four working days in the case of officers who have not less than five years' continuous service and by a further three days in the case of officers who have not less than 10 years' continuous service.

The leave year commences on 1 April and new entrants to the service will be entitled to leave proportionate to completed months of service.

This entitlement applies to five day working patterns. An equivalent leave entitlement will be calculated on a pro rata basis for alternative work patterns.

Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of

absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service	one month's full pay and (after completing four months service) two months half pay
During second year of service	two months' full pay, and two months' half pay
During third year of service	four months' full pay, and four months' half pay
During fourth and fifth years of service	five months' full pay, and five months' half pay
After five years' service	six months' full pay, and six months' half pay

Superannuation

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. He or she may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enrol the person appointed at certain times. The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) (www.nilgosc.org.uk).

Canvassing

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment. 
