- supporting the planning and implementation of strategic media relations programmes and campaigns and supporting departmental media relations activities; and
- providing support in the development and implementation of the council's marketing and corporate communications plan.

Be an ambassador for the Belfast city brand framework. Supporting the Brand and Marketing Manager in working with partner organisations to influence the use of the city brand framework within their profile, communications, activities and business objectives.

Summary of responsibilities and personal duties

- 1. Provide support for staff, elected members and the departmental senior management team by writing and editing internal and external high quality materials including speeches, marketing collateral, strategic messages, press articles, online and social media content, handling press enquiries, presentations and reports etc. to support a range of departmental and relevant programmes and projects.
- 2. Develop and implement departmental and relevant project and programme communications policies and plans that are consistent with both the corporate communications strategy and the departmental business plan for the business areas assigned to you (rotational).
- 3. Responsible for the provision of high quality written material and press briefings for a range of communications media in relation to departmental issues and other corporate programmes and projects.
- 4. Responsible for supporting the communications and community engagement activities, including organising news conferences, launches, photo calls in relation to any relevant corporate projects.
- 5. Contribute to an integrated Office of the Chief Executive and as a key player, working collaboratively with all staff in the marketing and communications function, to ensure a flexible, integrated approach to campaigning and contributing to the overall Marketing and Communications Strategy.
- 6. Contribute to a proactive approach and delivering public relations campaigns that will develop an energy around the Belfast Brand, Belfast City Council and the Belfast Agenda, showcasing successes and identifying opportunities.
- 7. Plan, manage, execute and evaluate the success of all activity and media impact.
- 8. Build working partnerships with communications professionals and relevant individuals within the council's Belfast Agenda plan and city partner organisations.
- 9. Participate in the successful delivery of a corporate digital strategy to enhance all aspects of service delivery and provision of information to ratepayers and stakeholders, in the context of the delivery of the Belfast Agenda and council activity.
- 10. Create and support an open communications culture and the sharing of knowledge within the team.
- 11. Prepare media plans for each department that are consistent with the council's corporate priorities, departmental business plans and the corporate communications strategy.
- 12. Attend council committee meetings and provide elected members and chief officers with professional advice on all aspects of media relations, report on media activity and proactively identify potential news stories relating to the council.

15. Build new relationships and maintain existing links with press and broadcast media and develop and maintain an effective contacts database.

- 18. Participate in the council's out-of-hours duty rota system for media contact.
- 19. Responsible for managing any temporarily assigned staff.
- 20. Assist in the development of a business plan for the section to ensure the delivery of an effective and efficient service.
- 21. Participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including, absence management, disciplinary and grievance procedure.
- 22. Participate as directed in the council's recruitment and selection procedures.
- 23. Act in accordance with council and departmental policies and procedures including customer care, equal opportunities, health and safety; safeguarding and any pertinent legislation.
- 24. Undertake the duties in such a way as to enhance and protect the reputation and public profile of Belfast City Council.
- 25. Undertake such other relevant duties as may from time to time be required.

Belfast City Council is the Data Controller under the UK General Data Protection Regulation (UK GDPR) for the personal data it processes relating to job applicants. Processing data from job applicants allows the council to manage the recruitment process, assess and confirm an applicant's suitability for employment and decide to whom to offer a job. It may also need to process data from job applicants to respond to and defend against legal claims.

Appointment

The appointment will be made by the selection panel but will be subject to ratification by the director of the relevant department.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department. These posts may be either full-time or part-time on a fixed-term basis.

If you are offered and you accept a temporary position e.g. a temporary part-time position for 3 months, and another temporary part-time position arises from the same recruitment campaign e.g. for 1 year, regardless of whether or not you are still working in your temporary part-time position, you will not be offered any further temporary part-time position. However, in certain circumstances, when all relevant applicants on the reserve list for temporary vacancies, full-time or part-time, have been offered opportunities for which they expressed a preference on their application form, and if the timing of the reserve list is still valid and there are still temporary vacancies to fill before the reserve list expires, the council reserves the right to 'revisit' the reserve list in strict order of merit. Remuneration

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Grade 8, SCP 34 to 37, £43,693 - £46,731 per annum (plus 10% allowance for out of hours working, where appropriate) (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

Location

The person appointed will be based initially in the City Hall, Belfast, but will be required to work in and/or visit other locations.

Pre-employment checks

Prior to taking up duty the person recommended for appointment must:

- (a) Enter into an agreement which sets out the main terms and conditions of employment.
- (b) Provide evidence of the right to work and reside in the UK via either:

- (f) Pass satisfactorily a medical assessment by the council's Occupational Health Service provider.

- (h) Complete a disclosure of criminal convictions form, under the Rehabilitation of Offenders (NI) Order 1978. Council policies

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

Conditions

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment.

A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.

Service and hours of duty

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and they will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

Annual leave

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 177.6 hours (24 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory

holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

one month's full pay and (after completing four

	months service) two months half pay
During second year of service	two months' full pay, and two months' half pay

During third year of service four months' full pay, and four months' half pay

During fourth and fifth years of service five months' full pay, and five months' half pay

After five years' service six months' full pay, and six months' half pay

Superannuation

During first year of service

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. They may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enroll the person appointed at certain times. Appointees (including for casual posts), who do not meet the criteria for immediate automatic enrolment, can opt to join the scheme by contacting Payroll in writing (email payroll@belfastcity.gov.uk). The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) (www.nilgosc.org.uk).

Canvassing

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment. Notice

The minimum period of notice to be given by an employee shall normally be the ordinary period from one payment of salary or wages to the next.
