

# Road Traffic Regulation (Northern Ireland) Order 1997

## Notice of Proposed Special Event

**Notice is hereby given** that Belfast City Council by virtue of the powers conferred on it by Article 8A of and Schedule 3A to the Road Traffic Regulation (Northern Ireland) Order 1997 is minded to make an Order to temporarily restrict or prohibit all traffic from using the following roads in accordance with the details in the Schedule hereto to facilitate the safe operation of filming organised by **Robert Huffam**. Where necessary, local diversions will be in operation, signed as appropriate during the times stated below or until the time the event is announced by the organiser as completed, whichever is the earlier, the right of way on the road, vehicles and other forms of traffic shall be restricted or prohibited.

### Friday 11 April 2025 – 8am to 6pm

- Closure of Cyprus Avenue (from North Road to Sandford Avenue)
- Closure of Kirkliston Drive  
(from Cyprus Avenue to a point 100m south of Cyprus Avenue)

### Tuesday 15 April 2025 – 8am to 7pm and Wednesday 16 April 2025 – 8am to 12noon

- Closure of Brunswick Street (from Howard Street to Franklin Street)
- Closure of James Street South (from Bedford Street to Brunswick Street)

### Thursday 24 April 2025 – 11am to 7pm

- Closure of Slievemoyne Park  
(from Antrim Road to junction at numbers 19 and 21 Slievemoyne Park)

### Monday 28 April 8am to 3pm Tuesday 29 April 2025

- Closure of Maryville Park (from Malone Road to number 77 Maryville Park)
- Closure of Myrtlefield Park (from Malone Road to number 50 Myrtlefield Park)

### Tuesday 29 April 2025 – 7am to 7pm

- Closure of Castle Street (from Donegall Place to Queen Street)
- Closure of Fountain Street (from Castle Street to Fountain Lane)
